4. COVID-19 Protocol

Health and safety are of utmost importance to Riversong Forest School. We operate in accordance with Quebec's official directives regarding COVID-19. As the health situation shifts and the directives change to meet it, we will update our protocol and send an email to all parents/guardians to inform you of the change.

The current protocol is as follows:

4.1 Children will not be required to wear masks or keep their distance from each other.

4.2 Adults (including Riversong staff) are required to wear a mask when they are less than 2m from others.

4.3 All participants and parents/guardians are requested not to share food or drink with others.

4.4 All participants and parents/guardians are requested to bring their own facial tissue and hand sanitizer, as well as a method for disposing of used tissue (plastic bag etc.)

4.5 In the event that a participant or attending parent/guardian:

- has symptoms of COVID-19, such as: fever, dry cough, shortness of breath, tiredness, sudden loss of sense of smell or taste OR
- lives with a person who has symptoms of COVID-19 or is in isolation because of COVID-19 (confirmed case or contact) OR
- has travelled outside of Canada in the last 14 days

the participant and parent/guardian must stay home.

5. Media consent

6. Assumption of risk / Indemnity agreement / Responsibility waiver

PLEASE READ THIS SECTION CAREFULLY; IT CONTAINS IMPORTANT SAFETY INFORMATION.

6.1. Being outdoors comes with inherent risks, and attending forest school in a natural environment has additional risks, such as the potential presence of poisonous plants, wild animals, sharp or slippery rocks, etc.

6.2. One of the key components of forest school philosophy is supporting risky play. Forest school practitioners aim to educate children and their parents/guardians about risks and how to assess and manage them during forest school sessions. Avoiding risks entirely does not equip children to deal with them safely when they encounter them later in life. At Riversong Forest School sessions, children are not forbidden from all conceivable risky actions. Rather, there are rules that will be enforced to prevent undue risk, while activities that come with minor risks will be prefaced by discussion, and parents/guardians are invited to decide together with their child what their level of comfort with a given activity is, and whether and how to participate safely.

6.3. While the practitioner leading Riversong Forest School sessions will do a site risk assessment before each session and remove or neutralize dangers (such as disposing of broken glass, or setting the site boundaries to exclude overhanging dead branches etc.), there is still the possibility of injury occurring.

6.4. Parents/guardians assume responsibility for the safety and well-being of their child during forest school sessions.

7. Fees and payment

The fees for the 2021 Fall semester are 180\$. The 90-minute sessions run once per week for 8 weeks. Payment can be made by e-transfer to millwardmegan@gmail.com or by cheque made out to Megan Millward. **Do not make a payment until after submitting this form and receiving confirmation of successful registration.**

In case of the COVID-19 situation leading to the cancellation of outdoor gatherings, each family can decide whether to opt for a refund of the cancelled sessions or to wait until the restrictions are lifted and sessions can be rescheduled.

8. Cancellation of individual forest school sessions

Riversong sessions take place in sunny, overcast, rainy, and snowy weather. Sessions are only cancelled/rescheduled if the weather forecast indicates dangerous weather, including but not limited to thunderstorms, hail, heat warnings or cold warnings. Whether sessions that cannot take place due to weather issues are cancelled (and refunded) or rescheduled will be decided in consultation with all parents/guardians.
